The University based on the (1) Recognition accorded by the National Council of Teacher Education, New Delhi (2) Based on the recommendations of Inspection Committee, has accorded approval for grant of extension of provisional affiliation to MNR Rural PG College of Education, MNR Nagar, Fasalwadi Village, Narsapur Road, SANGAREDDY, Sangareddy Dist to offer B.Ed Course with an intake of two basic units of (50+50) students for the academic year 2023-2024, subject to the fulfillment of the following conditions and general rules of affiliation.

CONDITIONS:

- 1. As per NCTE Regulations, 2014, the college has to appoint Principal with Ph.D. and (15) teachers as per the intake through duly constituted Selection Committee and obtain University approval.
- 2. To strengthen and establish all laboratories by procuring necessary infrastructure as per NCTE Regulations, 2014.
- 3. To purchase books worth Rs. 50,000/-.
- 4. To update faculty information on the University website.
- 5. To Provide lift facility
- 6. To upgrade all Labs.
- 7. To subscribe for (5) Educational Journals and (5) Journals in related discipline.
- 8. Teaching diaries and Students attendance registers are to be maintained as per norms. Attendance to be marked in the class room only.
- 9. Governing Body meetings are to be conducted thrice in a year by associating University representative on the Governing Body.
- 10. Lift facility need to be made immediately.
- 11. Issue ID cards to faculty and staff need to be issued.
- 12. Salaries to the staff should be paid through Online.
- 13. The College must display Time-Table on the notice board.
- 14. The College is required to maintain institutional records as given in proceedings No.423/AAC/96, dt 04-05-1996 and to keep them ready for inspection.
- 15. The College should remit the prescribed fee towards AAF/SRF/SRCF/SWF/ IUTF /Academic records, fees etc. as prescribed by the University from time to time.
- 16. The Management is warned not to admit the students over and above the ceiling strength.
- 17. The College should follow OU almanac strictly.

You are, therefore, directed to submit the compliance report on the fulfillment of the academic deficiencies in the following format along with the documentary evidences to reach this office with in a period of one month from the date of issue of these orders through the University representatives on the Governing Body of the college.

General conditions to be fulfilled by all the colleges:

- The College should appoint required qualified teaching staff as per the intake through duly constituted selection committee as per NCTE/OU norms, associating the University Nominee on the Selection Committee and Subject Expert and obtain approval of the Registrar, OU at the staff at the beginning of the academic year.
- 2. Attendance registers and teaching diaries are to be maintained properly. Attendance to be marked in the classroom only.
- 3. Non-Compliance of the conditions laid down by the University shall lead to withdrawal of affiliation.
- 4. The college is required to maintain institutional records as given in the proceeding No.423/AAC/96 date: 04- 05-1996 and to keep them ready for inspection.
- The College should remit the prescribed fee towards AAF/SRF/SRCF/SWF/IUTF/Academic Records Inspection fees, etc. as prescribed by the University from time to time.
- 6. The Colleges has to follow the University almanac strictly.
- 7. The College should display the Almanac & Time Table on the notice boards.
